America's First Daughter

If there was ever a time to read about **how women have shaped politics**, it has to be now! Our mothers, sisters, and female co-workers truly need to read this book. The authors recount the fascinating story of Thomas Jefferson's eldest daughter, Martha "Patsy" Jefferson Randolph.

Patsy was just a young girl when her mother passed away and on her deathbed asked that she take on the role of mother to her siblings and command of the household. After the American Revolution, at about age 12, she accompanied her father to Paris and assisted in his role as an envoy from the United States. From this point on, she took on the role of America's first daughter and worked alongside her father during his presidency and throughout the rest of his life.

Although she was well-educated, with her skills as a matriarch, she married and bore 11 children. Somehow she managed to care for them and her daughter's children after *she* passed away at an early age. When her husband became the Governor, she carried on with her role as the First Lady. Through years of enduring a rocky marriage and facing the eventual desertion by her husband, Patsy still managed to carry on as matriarch of the family. Even after her husband's death left her penniless and having to live off her relatives, her political knowledge along with artful diplomacy and hostess skills were still in demand. Recognizing her many years of service as First Daughter to President Jefferson and our country, President Madison asked for her help in assuming some of the duties as First Lady during his tenure in the Whitehouse.

Throughout President Jefferson's lifetime, letters and meticulous records were kept and the authors have quoted directly from many of these primary sources, all of which reflect the biases, prejudices, and political opinions of that revolutionary time period. This book is a chronicle for women of today's generation to learn from. The harsh reality of being pioneers in a country during its infancy, along with the roles and limitations placed upon women during earlier years are a wake-up call to AAUW women. This book will help women celebrate how far we have come through the years and realize just how much farther we have to go to achieve real equality!
